

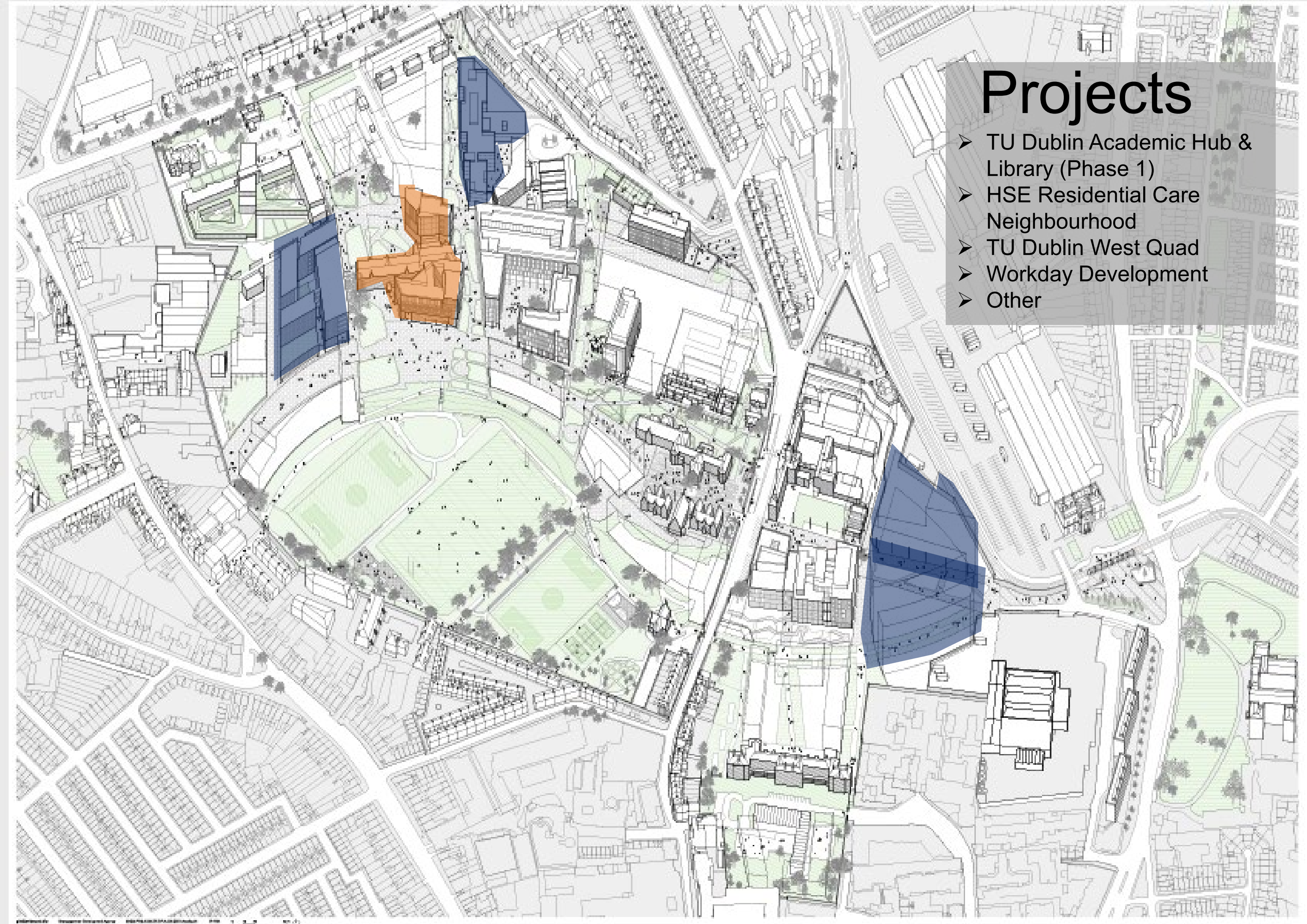

- A Public Information session will be held in advance of the works.

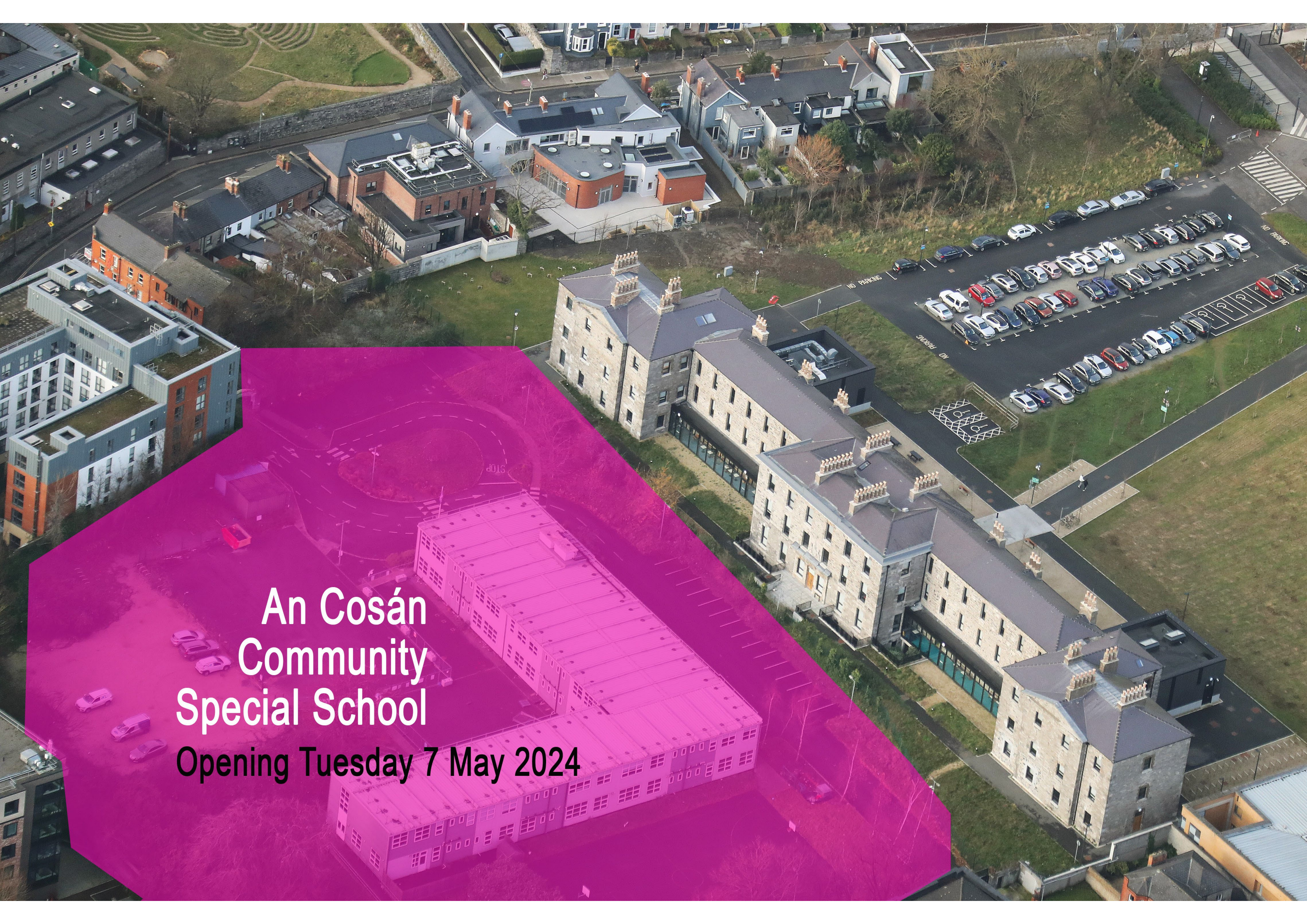
# Upcoming Planning Applications

- Public info session will be held in advance of planning submission.

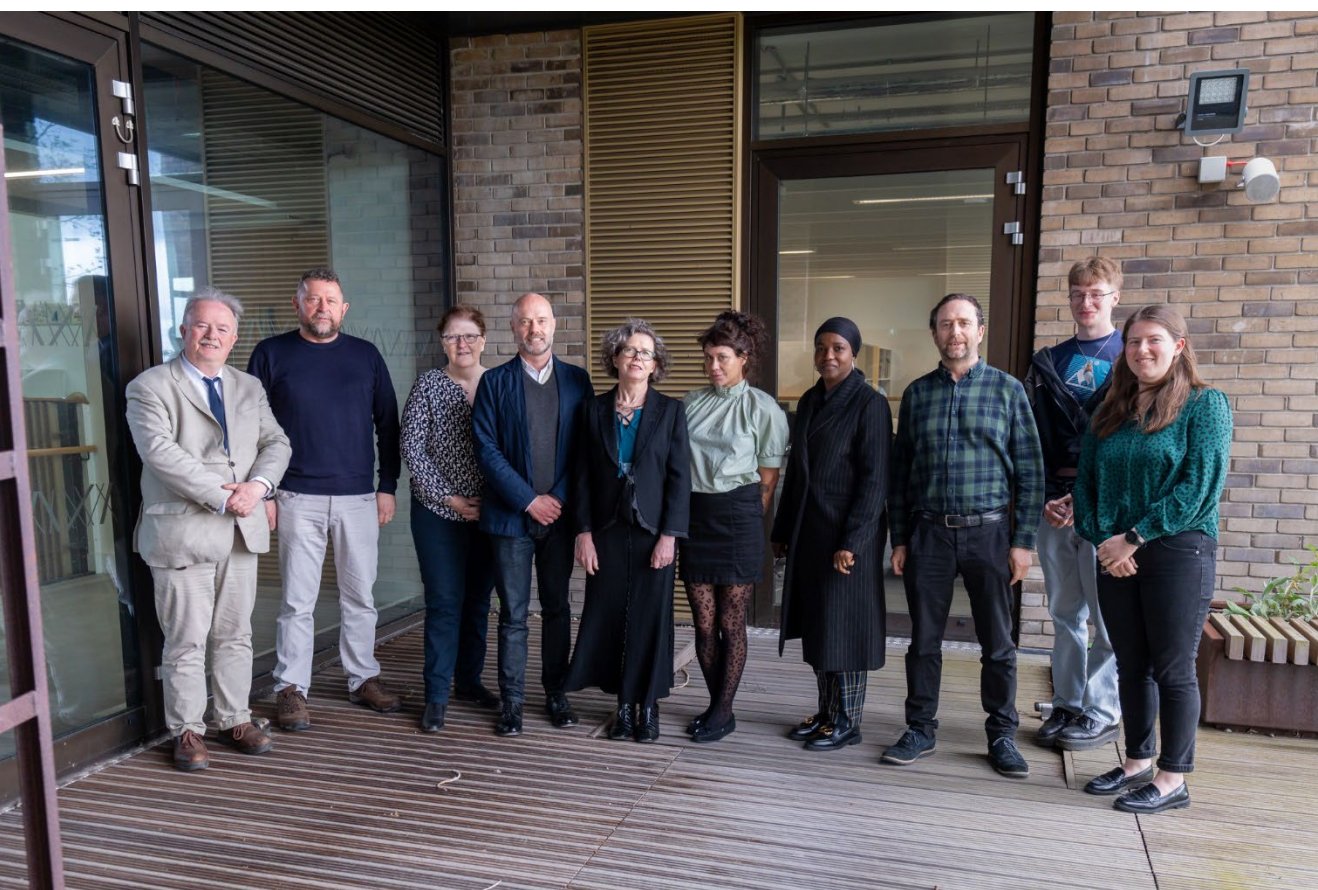
## Prussia St Gate Haul Road & Pedestrian/Cyclist Route

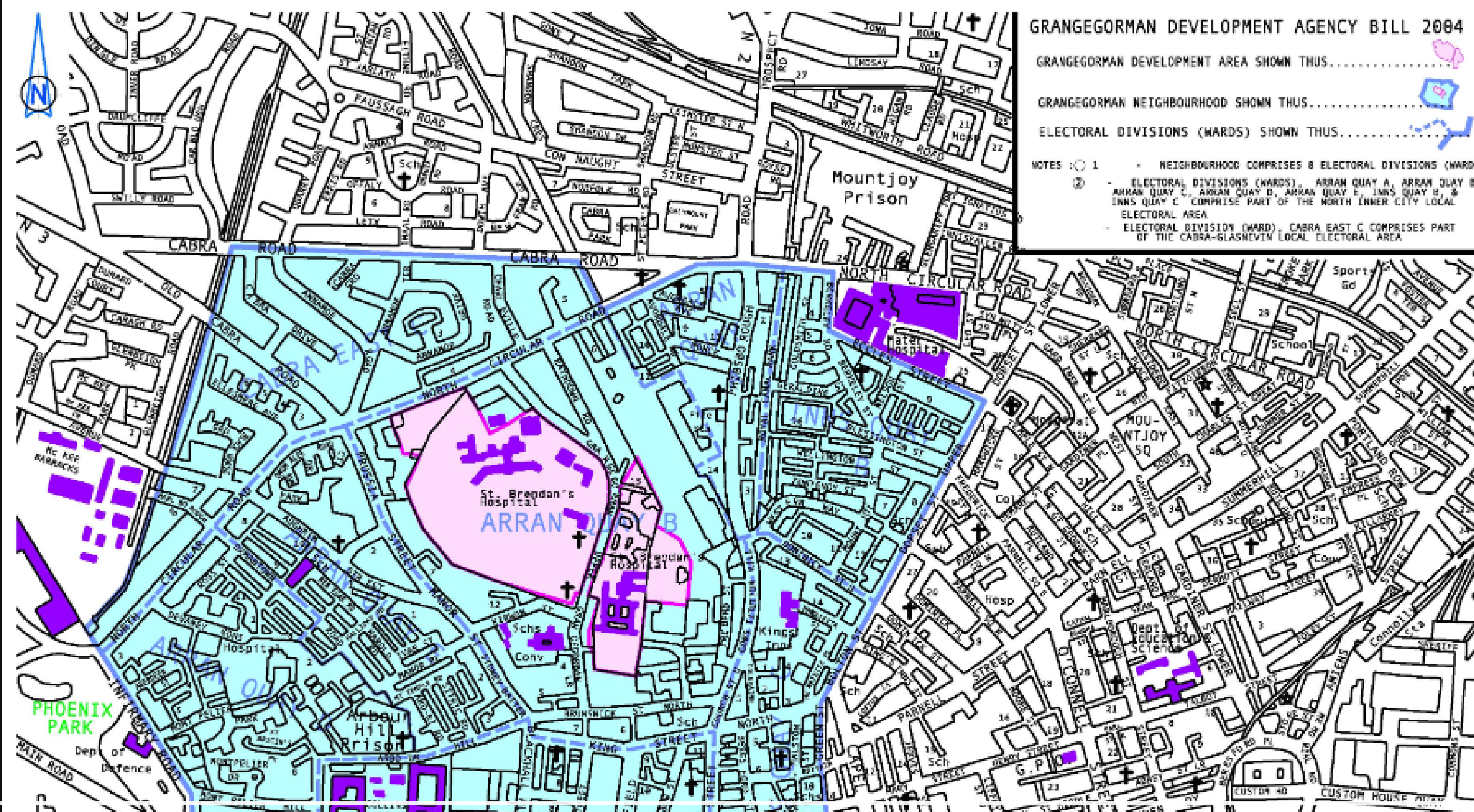
