- **2.1. CB** presented an update on activities in TU Dublin which included:
 - Summer Catering Hours:
 - Central Quad café, Rathdown House and Lower House restaurants closed.
 - Kennedy's East Quad and Kiosk are opened for June but closed July/August.
 - Park House café open all Summer.
 - No Summer camps taking place this year on campus.
 Camps will restart Summer 2026.

3. GDA Project Updates

- **3.1. DC** presented an update on GDA project which included:
 - Academic Hub Library:
 - Substantial completion date now moved from end of June to end of July.
 - After this testing and the commission of electrical and mechanical systems will commence.
 - Safety files to be prepared and to be acceptable to GDA and TU Dublin.
 - Any quality issues must be resolved before site handover.
 - Demolition at Area D: Archaeological investigations completed by IAC and managed by the National Monuments Agency, who will guide GDA on next steps of work on this area.
 - Planning & Traffic: Traffic Survey & Parking Survey was done in area for Grangegorman Junction Monday 24th-Thursday 26th and Saturday March 29th. The findings from both surveys showed that there is sufficient capacity in the area for junction traffic and local parking.
 - Communication to residents (126 households) via door drop (letter and FAQ document) estimated to commence 2nd week in July.
 - Intention to lodge new planning permission end of July.
 - West Quad: Procurement shortlist for property exchange established. GDA are working on the next stage of the procurement. The intention is to obtain approval to proceed with Stage II of the tender process by end of 2025.
 - HSE Residential Care Neighbourhood:
 - Query from DCC over EV charging in basement (30 points) re fire safety
 - Detailed business case due end of July
 - Once business case complete then can go to tender
 - Expected timeline to go out to tender was end of July 2025. Since meeting timeline has changed and tender is expected to go out August/September.
 - Prussia St Gate Haul Road & Pedestrian/Cyclist Route:
